## Instructions

### For adopted horses only:

**ALL APPLICATIONS** BEING SUBMITTED FOR HORSES WHICH WERE ADOPTED FROM THE BLM MUST BE ACCOMPANIED BY A COPY OF THE BLM TITLE OR A COPY OF THE EQUINE HEALTH & IDENTIFICATION RECORDS. IF THE HORSE WAS ADOPTED AS A FOAL WITH IT'S DAM, PLEASE PROVIDE THE INFORMATION ON THE DAM IN THE PROVIDED SPACE ON THE REGISTRATION FORM.

### For captive bred/born horses:

**ATTACH COMPLETED MARKINGS AND PEDIGREE PAGES.** WHEN FILLING OUT THE MARKINGS AND PEDIGREE PAGE, ONLY DESCRIBE *WHITE* MARKINGS. USE "FREE-ROAMING" TO INDICATE SIRES AND DAMS OF HORSES ADOPTED FROM THE BLM AND FOR THE SIRE OF A FOAL CONCEIVED IN THE WILD.

**FOALS OUT OF UNREGISTERED MARES** WILL BE REGISTERED IN THE APPENDIX REGISTRY UNLESS THE MARE IS BLM FREEZE BRANDED AND A COPY OF EITHER THE BLM *EQUINE HEALTH & IDENTIFICATION REDORD* (FRONT AND BACK) OR THE TITLE IS ATTACHED TO THIS APPLICATION.

### For all horses:

**PHOTOGRAPHS:** APPLICATION FOR REGISTRATION OF HORSES MUST BE ACCOMPANIED BY **FOUR** COLOR PHOTOS. PHOTOS SUBMITTED MUST BE: 1 FRONT VIEW, 1 REAR VIEW, 1 LEFT SIDE VIEW AND 1 RIGHT SIDE VIEW. THE HORSE'S OWNER'S NAME MUST BE WRITTEN ON THE BACK OF ALL PHOTOS. IF THE HORSE'S OWNER IS NOT THE PHOTOGRAPHER, AND THE PHOTOGRAPHER OWNS THE COPYRIGHT FOR THE PHOTO, THE HORSE'S OWNER MUST SUBMIT A CONTRACT OR STATEMENT FROM THE PHOTOGRAPHER INDICATING THE HORSE'S OWNER HAS BEEN PERMITTED USE OF THE PHOTO. IF THE OWNER OF THE COPYRIGHT DOES NOT WISH THE PHOTO TO BE USED BY THE SULPHUR HORSE REGISTRY FOR PURPOSES OTHER THAN REGISTRATION, PLEASE INDICATE SO ON THE BACK OF THE PHOTO.
